1. Target Audience and Purpose

This document specifies technical interoperability requirements for connection to operational endpoints in the National Identity Exchange Federation (NIEF). The target audience includes technical representatives of organizations that intend to participate in NIEF as Identity Provider Organizations (IDPOs), Service Provider Organizations (SPOs), Service Consumer Organizations (SCOs), Attribute Provider Organizations (APOs), or some combination of these roles.¹ It also includes vendors, contractors, and consultants who, as part of their project or product implementation, have a requirement to establish technical interoperability with NIEF endpoints.

This document focuses only on issues of technical interoperability. It does not cover governance, policy, or other nontechnical interoperability requirements. For more information about those topics, see [NIEF Bylaws] and [NIEF OPP].

2. NIEF Identity Trust Framework and Terminology

This document is one component of the NIEF Identity Trust Framework. See [NIEF OPP] for more information about the full NIEF Identity Trust Framework.

This document contains language that uses technical terms related to federations, identity management, Web services, and other related technologies. To minimize confusion for readers, it is important that each technical term have a precise definition. Accordingly, all technical terms in this document are to be interpreted as described in [NIEF Terms].

5. NIEF Attribute Profile

This *NIEF Attribute Profile* specifies the following constraints on NIEF Identity Provider Organizations (IDPOs) regarding assertion of attributes from the NIEF Attribute Registry.² Note that a requirement to support a particular attribute does NOT imply a requirement to assert a particular attribute in every assertion for a user.

1. Support for the following user attributes is MANDATORY. Every NIEF IDPO MUST be able to assert them on behalf of its users, when requested by NIEF Service Provider Organizations (SPOs).
 - a. Federation Id (gfipm:2.0:user:FederationId)
 - b. Given Name (gfipm:2.0:user:GivenName)
 - c. Sur Name (gfipm:2.0:user:SurName)
 - d. Email Address Text (gfipm:2.0:user:EmailAddressText)
 - e. Telephone Number (gfipm:2.0:user:TelephoneNumber)
 - f. Employer Name (gfipm:2.0:user:EmployerName)
 - g. Identity Provider Id (gfipm:2.0:user:IdentityProviderId)

2. Support for the following user attributes is HIGHLY RECOMMENDED, as they are required for access by two or more NIEF resources. Every NIEF IDPO SHOULD be able to assert them on behalf of its users, when requested by NIEF Service Provider Organizations (SPOs).
 - a. Sworn Law Enforcement Officer Indicator (gfipm:2.0:user:SwornLawEnforcementOfficerIndicator)
 - b. Public Safety Officer Indicator (gfipm:2.0:user:PublicSafetyOfficerIndicator)
 - c. Employer ORI (gfipm:2.0:user:EmployerORI)

- d. Employer Organization General Category Code

 - b. Counter Terrorism Data Self Search Home Privilege Indicator
